Proposed Action Title: Salvage Yard Scrap Metal Cutting Activity

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Large items designated and approved as scrap metal for the Salvage Yard will be cut down to ensure they fit into 30-yard roll-off pans. These pans are required for the safe and efficient transport of materials offsite to an approved vendor for scrap metal recycling. All scrap metal received at the Salvage Yard is collected in roll-off pans and stored onsite until routinely picked up by the vendor as part of standard Salvage Yard operations.
