Proposed Action Title: Removal of Low Activity Waste Vault (LAWV) Cell 11 Waste Repackaging Facility Rain Collection Poly Bottle.

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The drain valve on the E-Area Low Activity Waste Vault (LAWV) Cell 11 HVAC exhaust stack will be closed and a poly bottle used to collect any rainwater/condensate shall be removed. The Waste Repackaging Facility (WRF) is in layup while awaiting D&R from Cell 11 and the poly bottle has remained dry with no liquid collected.
