Sanitary Landfill Permit Modifications Requested

The United States Department of Energy (USDOE)-Savannah River Operations Office has requested from the South Carolina Department of Health and Environmental Control (SCDHEC) a modification to Savannah River Site's (SRS) 2000 Resource Conservation and Recovery Act (RCRA) Part B Permit Renewal Application for Volume XXIII. This modification details operations at the Sanitary Landfill.

Modifications to Volume XXIII (Revision 3 of the 2000 application) document the results of the characterization efforts for radium-226, radium-228, 1,4-dioxane, and gross alpha, and amend the Alternate Concentration Limit/Mixing Zone Request to include 1,4-dioxane. Changes were also made to the Revision 3 document so that the Permit Application and Permit are in agreement.

This notice begins a 60-day comment period. More information, including the actual permit application, is available for review and copying at the USDOE Public Reading Room located in the University of South Carolina-Aiken Library, or by contacting personnel identified in this notice. The Permittee's compliance history during the life of the permit being modified is available from SCDHEC.

A public meeting will be held on Wednesday, September 8, 2004, 3:00 p.m. at the Aiken County Public Library. Representatives from SRS will be available to answer questions on the modification. Written comments may be sent to SCDHEC. All comments will be considered in the final decision.
