United States Department of Energy Savannah River Operations Office Hazardous Waste Permit Application Modification Request

The United States Department of Energy (DOE)-Savannah River Operations Office has requested from the South Carolina Department of Health and Environmental Control (SCDHEC) modifications to Savannah River Site's (SRS) 1992 Resource Conservation and Recovery Act (RCRA) Part B Permit Renewal Application for Volume V. These modifications detail changes to H-Area Hazardous Waste Management Facilities (HWMF) drainage system.

This revision (Revision 24 of Volume V) proposes to change the design of the drainage system around the closed H-4 seepage basin. This change was requested by the SCDHEC.

This notice begins a 60 day comment period. More information, including the actual permit applications, is available for review and copying at the DOE Public Reading Room located in the University of South Carolina-Aiken Library, or by contacting personnel identified in this notice. The Permittee's compliance history during the life of the permit being modified is available from SCDHEC.

A public meeting will be held on Wednesday, October 19, 2005, 3:00 p.m. at the Aiken County Public Library. Representatives from SRS will be available to answer questions on the modifications. Written Comments may be sent to SCDHEC. All comments will be considered in the final decision.
